Current Conditions

Directly or indirectly, most nonprofits are feeling the impact of the current policy environment.

Information Emergency	Rapid news cycles, conflicting updates, limited guidance from funders, and few trusted sources of clear, reliable information
Leadership Stretch	Burnout, staff strain, and stalled decisions as leaders face rising needs, shifting expectations, limited support
Muted Voices	Fear of retaliation, leaders seeking collective action and advocacy opportunities
Missions Under Pressure	Scrutiny of orgs serving vulnerable communities, particularly orgs working in multiple targeted mission areas
Sector in Limbo	Many are frozen, delayed, or reinventing without clarity about the future

Financial Limbo

Funding and programming conditions reported by local nonprofits

Frozen

Programs halted due to stop-work order or funding suspensions

Delayed

Funding on hold, but expected to resume after administrative, legal, or political resolution

Fractured

Some funding sources remain, but others are paused, causing operational strain

On the Edge

Grants/contracts nearing expiration with no clear renewal path

Constrained

Stable funding, but regulatory or policy shifts hindering service delivery

Reinventing

Seeking new strategies: mergers, fiscal sponsorships, or alternative revenue... closure.

Survey Background & Reach

Survey Background

Purpose:

In the context of destabilizing disruptions from Washington, DC, the Nonprofit Leaders Group initiated a needs assessment survey to help the region's nonprofit service organizations, associations, funders, and policymakers identify what would be most helpful to the sector at this time.

Background:

Developed as a rapid assessment tool to capture local nonprofit perspectives on policy shifts and funding disruptions, and to surface priority needs for support, technical assistance, and coordination.


Outreach By: Funders, nonprofit associations, nonprofit service organizations

Dates Open: March 20 – April 11, 2025

Limitations:

- Individual perspectives, not org positions
- English-only survey and meetings
- Varied degree of impact across respondents
- Sample size limited data analysis

Who We Heard From



Overall

- 607 respondents
- 362 organization names shared
- 130 Greater Philadelphia service zip codes (5-county)
- Majority shared open-text responses
- 56% were open to follow-up


Organizational Profile

- 3. What are the top ZIP codes where you provide services?




Primary Services

Federal Impacts from Survey

Funding uncertainty, staff strain, and stalled decision-making are widespread


49% of respondents reported **delayed or disrupted public funding**

36% cited staffing stress or instability, including freezes, role reductions

28% said funding uncertainty had stalled planning or decision-making

"The uncertainty is debilitating. The need escalates, but concern over looming cuts is stifling."

Organizational Concerns

What is your organization's greatest concern right now?

Prevalent Themes

Already Precarious: "Our organization took on a lot of debt during covid and we're in a precarious place now with the funding cuts where we may not survive the year."

Mission Conflicts: "We are concerned that we may be bound to executive orders that do not align with our values in order to receive future and current funding."

Perpetual Uncertainty: "We continue to put together complex and burdensome federal funding applications, but there is always the possibility that those funding avenues are cut the next day."

Federal Budget: "Our greatest concern is if funding for FY2025 will be allocated for programs and service come 7/1/2025."

Private Philanthropy: "My concern is the increased demand on private foundations and the increased competition for the same (or possibly less) funds."

Business Overhaul: "We need to rethink our entire business model."

Community Concerns

What is your organization's greatest concern right now?

Prevalent Themes

Fear & Anxiety: "Our clients are afraid to leave their homes. They are keeping their children out of school. This is a dire situation."

Ripple Effects: "Even a temporary disruption in services can lead to delayed prenatal care, gaps in early childhood development, and increased stress in the home"

Most Vulnerable: "Funding freezes are taking money and services from the people who need it most. We are harming marginalized people, and it is gut wrenching."

Partner Impacts: "Funding cuts/eliminations for organizations that we partner with... and that impact on our organization and clients we serve."

Lifeline Services: "Homeless services through HUD are a lifeline—can't afford to lose them"

Workforce Impacts: Despite "the astronomical rise in cost of living, our government is threatening to take [childcare] funding away."



Funding Needs


300+ respondents selected "financial resources" as a top need.

Themes	Key Points
Bridge Support	Flexible grants are needed to help organizations withstand delayed or disrupted funding.
General Operating	Unrestricted funding allows greater ability to plan and manage as conditions change
Sustained Investment	Long-term shifts in public funding would require multi-year support to rebuild


"We just need a bridge grant to get through this fiscal year. If we lose state funding-because they lost federal grants-we'll have to lay off people."

Many reported compounding pressures: delayed reimbursements, frozen contracts, and increased competition for private dollars.

Reflections & Next Steps

Protective Factors

Some organizations are faring better than others due to existing capacities and experience.

Legal Guidance	Interprets executive orders, funding terms, compliance risks
Gov't Affairs or Lobbyist	Tracks policy shifts, provides strategic insight, supports advocacy
Financial Reserves	Flexibility during delays, disruptions, or unplanned expenses
Internal Capacity	Enables planning, change management, staff support
Experienced Board	Governance, expertise, access in legal, policy, communications
Funder Relationships	Honest dialogue, flexibility, responsive adjustments
Change Management	Proactive planning, scenario testing, and confident adaptation
Support Networks	From technical expertise to emotional support, networks and associations are in overdrive.
